Program operating dates by county:

Orange: June 9th and August 12th.

Osceola: June 5th through August 9th.

Seminole: May 27th through August 9th.

Brevard: May 25th through August 9th.

Breakfasts, lunches and snacks delivered daily from Monday through Friday.

Requirements:

- Be located in a low income area of high need. The nearest school should be at 50% or above free and reduced lunch rate.
- Be a non-profit organization or a church.
- Be willing to operate at least 40 of the 53 scheduled dates.
- Have running water, refrigeration, shelter and adult supervision.
- Have at least 35 children who will attend on a regular basis.
- Attend an orientation at Second Harvest Food Bank at 411 Mercy Drive in mid-May.
- Be able to supervise a structured meal service at your site.
- Be able to complete paperwork and track daily meals served.

- Be an “open” site, which means giving access to all children 18 or under.
- Have someone at the site to receive food between 8:30 – 11 am

This program relies on your staff or volunteers. Second Harvest is a state approved sponsor. No monetary compensation is made to participating sites. Although the primary purpose of this program is to provide free food to sites that already have activities planned for summer, we also welcome sites that have limited programmatic activity. Participation in the program not only defrays your operating costs, but attracts more parents and their children to your site.
